It was interesting to learn that the maximum tax on any boat is \$18,000 or 6% whichever is the *Least*, which was put in place to curtail purchasers from acquiring boats in zero or reduced tax havens, bringing purchasers back to the USA. We also attended the *Bradenton Riverwalk Festival*, attracting visitors from all over the world. The F1 racing included to participants from Ontario.

I continue to try and get members to participate in "Muddy Waters", however to date with limited success. Annual Fees:

Work Hours 2017:

We will be using the reporting method started last year on line for work hours. We will also be returning to detailed individual invoices for annual fees. ALL work hours will be submitted by October 31st OR WILL BE LOST. Key Initiatives

DOCK BIDDING

Dock Bidding is something that up until 2015 was generally a non-issue in April at the first General Meeting of the year. However, between 2015 and 2016 the club welcomed some 17 new members to the club, creating a difficult situation for the Fleet Captain (**Al THIBERT** retired) who was in charge of making everyone happy with the dock assignment. Kudos go out to Al for looking after this very complex procedure. Unfortunately Happy was not always the case and the new **Fleet Captain KRISTI METCALF**, finds herself again with a number of members looking to participate in the Dock Bidding Process as many of the docks had been assigned on a temporary basis. The following is a Question and Answer overview which I trust will aid existing members looking to move, along with recent new members looking to be assigned a permanent dock. I trust this helps make the process a smooth operation and that at the end of the day everyone is happy.



THE FOLLOWING Q & A WILL HOPEFULLY AID IN THE UNDERSTANDING OF HOW THE "DOCK BIDDING" PROCESS WORKS

- **HOW DO I KNOW WHICH DOCKS WILL BE AVAILABLE TO BID ON?** The Fleet Captain will advise the paid up membership as to which docks are available in the notice of the Spring General Meeting. (Section 3 Rule 3.5b)
- **HOW IS SENIORITY DETERMINED?** This is based on the date on your initial membership cheque. A listing of Seniority has been mailed out to all members.
- **CAN A MEMBER BID BY PROXY?** Yes proxy bids are acceptable. (Rule 3.5d)
- **WHICH DOCKS ARE OPEN FOR BIDDING?** 1) Docks that are vacant because members have left the club, b) docks that were assigned mid-season in the preceding year to new member(s), c) docks left vacant by a full or probationary member who during the dock bidding procedure successfully bids on another dock.
- **WHAT IS THE BIDDING ORDER?** By seniority of membership provided that the size and draft of the member's boat are appropriate to the size of the dock available. (see KYC Rules/Regulations 3.5e)
- **CAN PROBATIONARY MEMBERS BID ON A DOCK?** Yes, at the annual spring dock bidding, in accordance with seniority. A dock thus acquired '*belongs*' to that member until he/she chooses to bid on a different dock.
- **WHAT ABOUT NEW MEMBERS?** Members who join during the boating season are assigned a temporary dock by the Fleet Captain — if a suitable dock is available.
- **DOES THE TEMPORARY DOCK ASSIGNED TO A MEMBER WHO JOINS MID-SEASON 'BELONG' TO THAT MEMBER OR IS THAT DOCK OPEN FOR BIDDING THE FOLLOWING YEAR?** It is open for bidding the following year.
- **WHO HAS THE FINAL SAY?** According to KYC Rules/Regulations, Section 3.5h Dock Bidding and Assignments, the Fleet Captain may assign docks if necessary after completion of dock bidding.

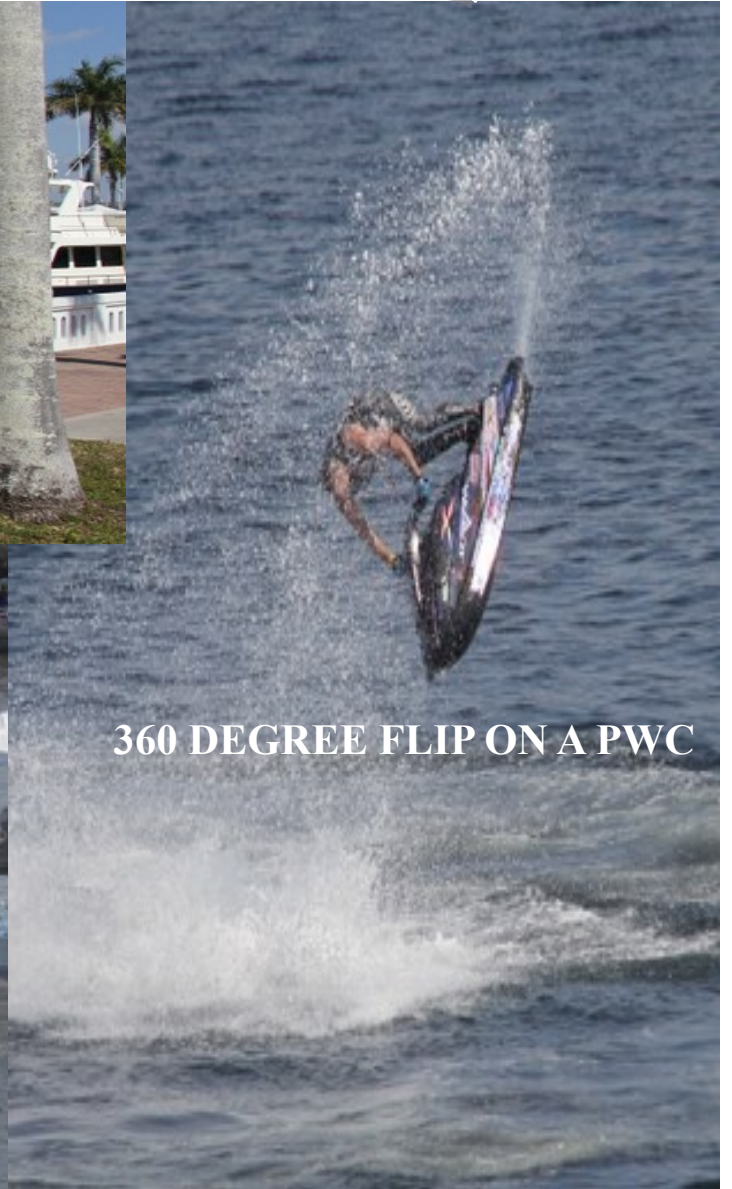

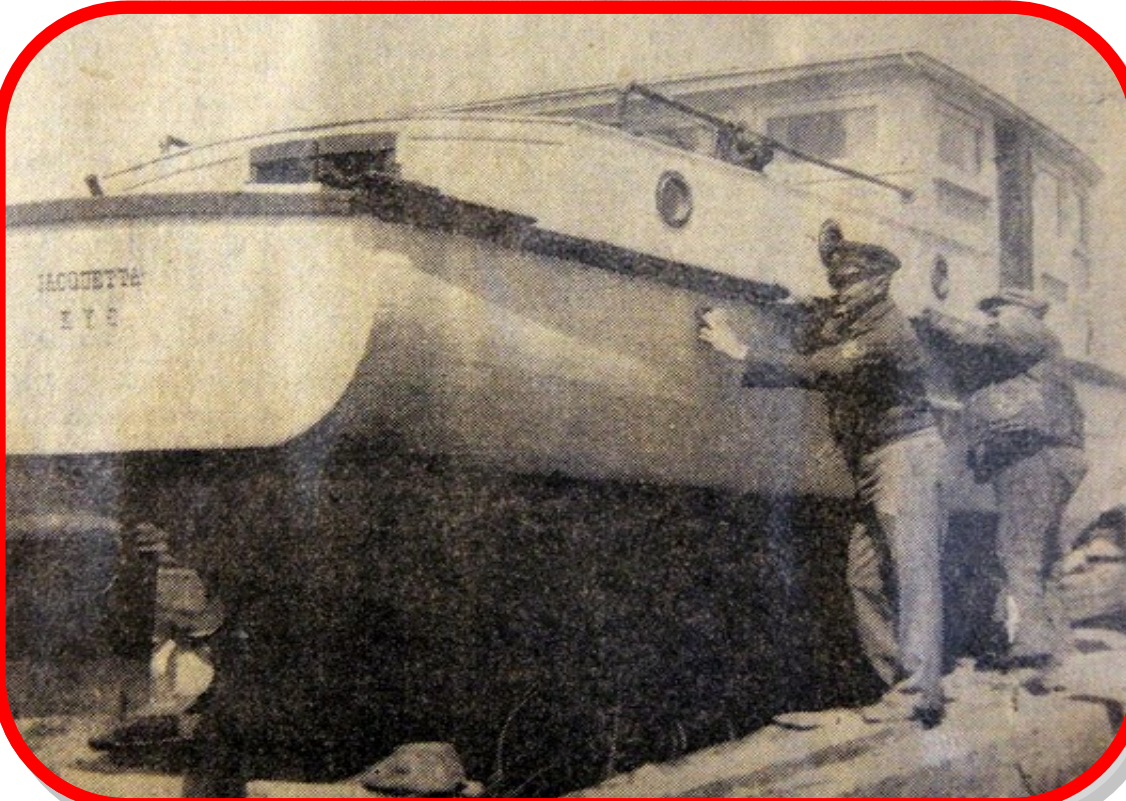
Yachtsmen Preparing For Season At Port Stanley

4. Great Lakes Ice Cover

Usually at this time of the year, we could expect the ice cover on the Great Lakes to be at about 60%. However, this year it is a mere fraction of that - about 8%.

Notwithstanding several recent winters of extensive ice cover, bone-cracking cold temperatures and significant snowfall, the long-term trend has been for warmer temperatures and reduced snowfall. This has implications for us as boaters. Extensive ice cover significantly slows evaporation and heavy snowfalls add to the volume of water in the lakes and in the streams and rivers of the entire Great Lakes basin.

Current ice cover for each lake as at the end of January is:

- > Lake Ontario 1%
- > Lake Erie 1%
- > Lake Huron 15%
- > Lake Michigan 12%
- > Lake Superior 7%
